Annual Wright Brothers Dinner celebrates the anniversary of flight

Our guest speaker, Debbie Harding, has been flying hot air balloons for over 30 years and has flown over five continents. She owns and operates Air Ventures, Inc. a commercial balloon flight business in Chester County. She also manages the annual Chester County Hot Air Balloon Festival. Debbie presented photos and stories about her ballooning adventures leading up to an historic trip to the North Pole where she became the first woman to fly a hot air balloon over the North Pole. She spoke about the challenges of transporting a balloon and a support team into and from northern Russia to the North Pole.


A friend recently gave me a copy of The American Heritage History of Flight. Published in 1962 it traces the history of flight from Icarus and Daedalus to, just barely, John Glenn's first orbital space flight. I discovered that while reading my Aero Club of Pennsylvania antennae would vibrate as I

picked up on significant aviation events and people that originated in our Delaware Valley area. Previously these items would likely have passed without much recognition.

For example, we all know the significance of ballooning in Philadelphia (see Debbie's article on pg 4), but did you

know about our area's contribution to dirigibles? The structural components of the Navy's first rigid airship, the USS Shenandoah (ZR-1) were built in the Naval Aircraft Factory at the Philadelphia Navy Yard in the mid-1920s; the final assembly being done at the blimp facility in Lake-

hurst. The fleet ultimately grew to five airships, but I believe only the ZR-1 came from here. All but the Luftschiffbau Zeppelinbuilt USS Los Angeles (ZR-3) were lost in accidents in little more than a decade. However, given the US availability of the rare and expensive helium lifting gas none suffered the incendiary failure of the Hindenburg. I highly recommend reading the available literature on airships – they are quite interesting machines.

All this history rambling brings me to our upcoming event – an Aviation History Scavenger Hunt. A crack committee is hard at work putting together a contest in which, after

flying to various local airports, contestants will compete for cash and (hopefully) prizes by answering questions that show their knowledge of aviation history in our tristate environs. The area is rich in history, so start studying! Blue skies - Bob



Aero Club History: Above Philadelphia

Recently, Ralph A. Jennings contacted the Aero Club shortly after seeing a newspaper article about our organization and the First Air Voyage in America. He was wondering if his grandfather, W. N. Jennings, was an early Aero Club member. He thought the club might be interested because Jennings may have been the first to take an aerial photograph from a balloon. Later, he flew with Victor Dallin (Aero Club President in 1948) in a Bellanca biplane for a new company, the Aero Service Corporation, one of the first aerial survey companies. He also shared that his grandfather is credited with taking the first successful photographs of lightning. Indeed, W. N Jennings was an honorary member of the Aero Club of PA, along with self-proclaimed balloonetic, Samuel A. King, the Philly-based gas balloon manufacturer and pilot.

W. N. Jennings was not the first person to make an aerial photograph, however, in 1893, he was the first to photograph Philadelphia from the skies in King's balloon, the "Eagle Eyrie". In 1930, he was awarded the Wetherill Medal of The Franklin Institute in earth science for being the first to capture lightening by photograph. Jennings wrote two journals for the Franklin Institute; "Up

Members of the Ben Franklin Aeronautical Society of Philadelphia inside the partially inflated Ben Franklin gas balloon. They had to crawl in through the small gas balloon valve.

The Ben Franklin Aeronautical Society members included the first Aero Club of PA President Arthur T. Atherholt. In his "Up in a Balloon, Boys" publication, Jennings shares a story about asking Arthur to hold his feet down during a flight so that he could lean out over the side of the basket holding only on to his new camera to take the perfect shot. It made Arthur dizzy when he saw what Jennings was doing and he almost fainted- Jennings quotes himself then saying "And then, you Boob, I could have lost my new graflex (camera)."

If you want to learn more, Jennings Scrapbook and publications can be found at the Franklin Institute, one of the first Museums dedicated to the Sciences and technology in the United States.

Another Scrapbook and many glass photo plates are housed in the Philadelphia Library Company founded by Ben Franklin and is the first Library in America. It is located next to the Historical Society of PA, 1300 Locust St. in Philly.

The vast majority of Jennings photos are housed with the Dallin collection of more than 7,800 images at Hagley Museum in Delaware.

REGIONAL AIRPORT REPORT

December 2018

PHILADELPHIA INTERNATIONAL [PHL]

There is a plan to buy 15 acres for \$5.5 million next to the 135-acre Henderson Tract, which the city acquired early this year. This purchase is for the purpose of developing a massive new airfreight complex, but the city must first approve it. A design is in place to relocate Tinicum Island Road to enable cargo expansion. Improvements for baggage handling at terminals A/B and D/E are expected in 2019. Airport entrance roadway beautification has already begun. Underway also are various pavement maintenance projects.

NORTHEAST PHILADELPHIA [PNE]

Major reconstruction on runway 6/24 will begin in the spring and is expected to continue for several construction seasons. Construction continues on vehicle parking lot areas.

BRANDYWINE [OQN]

All of the obstructions located off airport property were removed as a step toward restoring night approaches. The airport is awaiting FAA approval to resume the night approaches. Review and approval for the LPV Approach Feasibility Study is continuing. The airport is negotiating with adjoining property owners to obtain temporary construction and permanent maintenance agreements. Governor Wolf announced \$150,000 state funding for the design of new hangar site infrastructure.

DOYLESTOWN [DYL]

Paving of grass tiedowns and construction of bypass taxiways are expected to begin in January and completed by the end of June 2019. A grant has been received for the rehab of runway 5/23 including paving and lighting. Design is to be completed in 2019 with construction scheduled for 2020.

HERITAGE FIELD [PTW]

Obstruction removal is continuing on the south side of runway 10. Snow removal equipment acquisition is anticipated in February. Taxiway rehab design will begin January 2019 and should be completed for bidding in June. Construction is expected in Fall 2019. Gov. Wolf announced \$261,525 state funding for new hangar design, taxiway access and an access road.

NEW CASTLE [ILG]

Phase 2 of taxiway B relocation is complete and phase 3 is scheduled for Spring 2019. DuPont VOR is being replaced with a modern "doppler" VOR (DVOR) which is less susceptible to errors from relections off of nearby buildings. The airport consultants are making revisions in the master plan update by FAA.

NEW GARDEN [N57]

The airport will address discrepancies identified by FAA/BOA in its compliance inspection. The LPV survey was submitted for verification November 2018 and the airport is awaiting review. The new airport "planimetrics and contours" have been completed and the Engineer has developed surfaces for evaluation once the data is approved. The township is completing a project to perform site preparation for the West Hangar Development. The project entails apron development, taxi lanes for (6) 60'x 60' unit hangars and

utilities to the building pads. Hangar owners will be able to develop hangars themselves. Site preparation will start in Spring 2019 and will take a year to complete.

QUAKERTOWN [UKT]

Construction is approximately 75% complete and should be finished soon for phase 3 of runway 11/29 approach obstruction removal. Seeding, mulching and planting will be done in Spring 2019. The airport is working on acquiring easements for properties under runway 11 and 29 approaches to allow access for phase 4 and 5 of obstruction removal projects. Design work of rehab and expansion of terminal apron project is complete, but on hold until obstruction removal work is completed.

RED LION [N73]

This facility is no longer a public use airport.

SOUTH JERSEY REGIONAL [VAY]

Elevation surveys around T-hangars are finished, but a decision is to be made about whether to construct drain around the hangars or to mill and pave around them. The permit application for the environmental study for obstruction removal is being prepared by the consultant for DOT review, after which it will be sent to DEP for review and action. The FAA has issued a final document for the environmental study of the runway widening/taxiway relocation project.

TRENTON MERCER [TTN]

Phase I construction rehab of runway 6/24 pavement, lighting and signage is completed. Reconstruction of taxiway D and rehab of taxiway G are 50-60% complete.

WINGS [LOM]

An easement agreement was obtained for the installation of a permanent obstruction light, expected to be completed in December 2018. An NTP (notice to proceed) was to be issued in December for the AWOS equipment. The SRE (snow removal equipment plan) was completed and submitted to BOA for review and approval. Wings Hangar Nights resumed in September with a presentation by AOPA Ambassador, Norm Isler.

Philadelphia Airport Podcasts

Since 2016, Chellie Cameron has been the CEO of Philadelphia International Airport. Over the last year, Chellie has been recording

podcasts that go behind the scenes of Philly International and Northeast Philadelphia Airport.

The podcasts, "Taking Off with Chellie Cameron" include episodes about the development at the airports, the artwork displayed at the airports, and international operations. The latest issue is "a Chat with Tuskegee Airman Dr. Eugene Richardson."

This is my second year at Purdue and I am still majoring in Professional Flight and minoring in Chinese. I am also still on the Purdue University Flight Team. I am leading one of the sub-set teams this year and joined several others. I am working as a dispatcher, which is a

great way to meet fellow pilots and earn money for tuition. I am finishing up the second half of my commercial training and beginning instrument training later this semester. I am taking 18 credits a semester while working in hope of graduating junior year summer to save a year's tuition.

My goal this summer is to earn my CFI at Chester County Aviation. I spoke with Steve, head of flight training, to get a sense of how local FBOs do CFI training. He gave me some great advice. I am working on my CFI lesson plans now so that it won't take long to earn my CFI because I hope to find other ways to build hours over the summer, possibly banner towing. It looks as if I'll be quite busy this summer – but good busy!

I hope you've enjoyed hearing a little bit about what I am up to, and I want to thank the Aero Club again for choosing me as a scholarship recipient. Not only does the financial aid reduce the burden of tuition, but also I've formed so many relationships through the club and have been able to take advantage of unique experiences. Bob Mills honored at meeting

On January 17, the Aero Club honored Bob Mills of the Philadelphia Seaplane Base by showing the year 2000 interview by Russell Davis of the Millville Army Air Museum. Mr. Davis joined us for dinner 19 years after the interview and offered some insight about interviewing Bob. Bob ran the seaplane base from just after WWII until he retired in 2000.

Pilot liability protection passed

On October 5, 2018, the president signed the FAA Reauthorization Act of 2018 which includes provisions to protect volunteer pilots who conduct flights on behalf of nonprofit organizations. Volunteer Pilots will no longer have to be concerned about liability in excess of the limits of their insurance coverage. Section 584 of the Act gives this protection applies to flights for, "patient and medical transport (including medical transport for veterans), disaster relief, humanitarian assistance, or other similar charitable missions."

The Air Care Alliance has been fighting for this legislation for over a decade with the support of aviation organizations including GAMA and AOPA. Senator Jim Inhofe's relentless efforts over the past several years have finally

resulted in the passage of this legislation. As a result, pilots will no longer fear that their good deeds could place their families at financial risk. Pilots who have refrained from charitable flying because of these concerns can now join the ranks of countless thousands of other volunteers who contribute their skills and resources for the public good. Non-pilot volunteers have long enjoyed the same protection under the Volunteer LIABILITY Protection Act of 1997.

We've been working on this legislation for over a decade.
